## ELECTRONIC VISIT VERIFICATION

### Missing Authorization and Member Checklist Sandata EVV Users

Your members will show up in your agency account when they are tied to a prior authorization from the Health Plan or when you have entered information into the AHCCCS EVV Service Confirmation Portal that links you as the provider for a member.

#### **Step One: Search for an authorization in the Sandata system**

You can check for the authorization by logging into the Sandata EVV system and searching via one of two ways:

- After logging into the Sandata EVV system, select the Client Module then select the Program tab. Active Authorizations can be seen in this menu. OR
- After logging into the Sandata EVV system, select the Authorization Module, select your authorized dates, enter the Authorization number and select to Search.

#### **Step Two: Identify the source for the authorization**

**If the service requires prior authorization**, the member's Health Plan will send the authorization directly to Sandata. It can take up to 72 hours for this information to load into your agency account.

- Note: If the member is served under Tribal ALTCS, the member's Tribal Case Manager will need to enter the authorization into the AHCCCS system. AHCCCS, in turn, sends the authorization to Sandata. Providers are able to check the status of an authorization by logging into the AHCCCS Provider Portal.

**If the member's services do not require prior authorization**, you will need to use the EVV Service Confirmation Portal. You can find more information on why and how to use this portal on our website at [www.azahcccs.gov/evv](http://www.azahcccs.gov/evv) under AHCCCS Service Confirmation Portal.

**Step Three: Consider some common issues authorizations or members are missing.**

Some common reasons members and authorizations may be missing from your Sandata account:

- **Medicaid is not the primary payer.** Only Medicaid-primary paid services need to comply with the EVV mandate. If your member has other insurance or another funding source (i.e. Medicare, private pay, Non-Title 19 service dollars) that will pay for the service, EVV is not required.
- **The EVV Service Confirmation portal is used instead of obtaining a Prior Authorization from the Health Plan.** Please note, as part of the process, service confirmations are sent to the member’s Health Plan to validate before sending to Sandata. If they determine the service confirmation is invalid, the Health Plan will not forward the information to Sandata.
- **You may be an out of network provider for the member.** You will need to follow up with the member’s Health Plan to obtain a Prior Authorization.
- **You have multiple provider IDs as an agency.** In Sandata, you will have multiple accounts for each provider ID. You will need to verify which account your member or authorization should be showing under.
- **The member ID is not actively enrolled with Medicaid.** Only active AHCCCS members (Title 19 eligible ) will be sent to Sandata. EVV is only required for members enrolled in a Medicaid program and receiving Medicaid covered EVV services.

**Step Four: If the issue is still unresolved, please use the information and directions below to reach out to the member’s Health Plan to resolve an authorization issue. Please be sure to mention EVV to ensure your request is routed appropriately.**

If your Health Plan has confirmed that the authorization was sent to Sandata, please open a new ticket by emailing Sandata at [AZCustomerCare@sandata.com](mailto:AZCustomerCare@sandata.com). Please be ready to provide the client Medicaid ID, your 6 digit AHCCCS provider ID, and authorization reference number to open your ticket. You can also choose to call Sandata Customer Care at 855-928-1140 for assistance and provide the necessary information.

**Step Five: Record EVV for a missing member or a member with a missing authorization**

To continue providing services and recording EVV visit information for a missing member or missing service authorization, the caregiver will use the “Start Unknown Visit” feature. You can find recorded training sessions on the “Start Unknown Visit” feature here:

It is important to note that when starting a visit for an unknown member, the user will type the name of the client when they start the Unknown Client visit. The name that they enter is transposed to the memo field of the recorded visit in EVV.

An exception for the authorization will flag on the visit. Once the authorization issue is fixed or you have a new authorization issued, you can clear the exception and link the authorization to the visit in order to bill for the visit.
