CYE 2014 Contract Amendments

- ❑ Draft contracts sent on 08/01/13
- ❑ Feedback on draft contracts requested on or before 08/15/13
- ❑ AHCCCS is reviewing questions/concerns posed by Plans
- ❑ Final contracts will be provided no later than 09/02/13
 - ❑ Summary of changes that have been made subsequent to 08/01
 - ❑ Responses to questions/concerns issued by each Plan



CYE 2014 Transition Update

- Approximately 160,000 members will be transitioned on 10/01/13
- Enrollment notices sent to members throughout July
- Initial transition of member information from ADHS to United CRS - 07/11/13
- Initial transition of member information from Acute Contractors to United CRS and from United CRS to ALTCS E/PD – 07/26/13
- RBHAs will transition member information to United CRS on 08/23/13 (refresh on 09/23)
- 09/10/13 Transition of Member Information
 - Acute Contractors to United CRS (refresh on 09/24 and 10/09)
 - United CRS to ALTCS E/PD (refresh on 09/24 and 10/09)
 - Acute to Acute (refresh on 09/24, 10/02 and 10/09)
- Bi-weekly transition calls to troubleshoot outstanding issues



CYE 2014 Transition Update

- ❑ Readiness assessment of new Acute Plan, Acute Plans expanding into new geographic service areas and United CRS
- ❑ Acute Care
 - ❑ Monthly reports on the 15th of the month
 - ❑ 3 of 5 Contractors have closed out over **90%** of evaluation elements under review as of 07/15 report
 - ❑ 08/15 reports currently under review
- ❑ CRS
 - Monthly reports on the 1st of the month
 - United CRS has closed out **94%** of evaluation elements under review as of the 08/01 report



CYE 2014 Operational Reviews

- All Contractors will be reviewed in CYE 14
- Reviews scheduled for September 2013 – August 2014
 - Plans received final schedule on 07/29/13
- Tool has been revised to reflect new contract requirements and update formatting (inclusion of suggested documents)
 - Plans will receive tool with initiation letter, 3 weeks before on-site review
