
Per the request of Arizona Health Care Cost Containment System (“AHCCCS”), Arizona Complete Health-Complete Care Plan is submitting the enclosed plan outlining our commitment with respect to its plan members in the South GSA. Separately, and concurrently with this submission, Care1st Health Plan Arizona, Inc. is submitting two transition plans, one for the Central GSA and one for the North GSA; such.

As discussed in the enclosed commitment plan, the South GSA will at the time of closing continue to operate under the Arizona Complete Health-Complete Care Plan name, processes and platform. Centene Corporation (“Centene”) and WellCare Health Plans, Inc. (“WellCare”) do not expect any changes for members, providers or daily operations in this service area.
