Published Policy Revisions

• Chapter 100, Policy 108 – AHCCCS Security Rule Compliance

This Policy was developed to provide Contractors the requirements and compliance checklist tool for the annual data security audit. Attachment A is included as a link directly below the ACOM Policy on the web page.

• Chapter 200, Policy 203 – Contractor Claims Processing by Subcontractors

This Policy was updated to ensure consistency with current contractual requirements, procedures and protocols. This policy stipulates requirements for the adjudication and payment of claims and encounters by a subcontractor

• Chapter 400, Policy 401 – Change of Contractor: Acute Care Contractors

This Policy was updated to ensure consistency with current contractual requirements, procedures and protocols. This policy establishes guidelines, criteria and timeframes for how, when and by whom Contractor change requests will be processed for AHCCCS members outside of Contractor choice offered upon initial enrollment and the Annual Enrollment Choice (AEC) period. • Chapter 400, Policy 427 – CRS Contractor No-Show
