From April 1, 2024, to May 1, 2024, the population increased by 1,897 members, or less than 1%.

The major increases in the AHCCCS population from April 1, 2024, to May 1, 2024, were:

- 1.155 KidsCare
- 780 Emergency Services
- 730 SOBRA Pregnant

The major decrease in the AHCCCS population from April 1, 2024, to May 1, 2024, were:

- 2,197 Prop 204 Restoration
- 1,177 AHCCCS for Families & Children
