Those who were not also ineligible for another reason are included in the "Administrative" category. Beginning in September 2009 only Medicaid eligibility is determined for adults. Beginning January 2010 KidsCare enrollment is capped.

<sup>3</sup> KidsCare Children found eligible for and moved to Medicaid, but retained in the AHCCCS ACE eligibility database.

<sup>4</sup> During November 2010, 7,323 children and 5,271 adults who were eligible for Medicaid were transferred to DES because the household is Medicaid eligible, and no one is receiving KidsCare.
