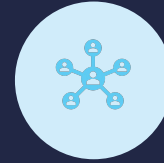

Peer to Peer Coaching

- Group or 1:1 Coaching is available
- Involvement and Information shared is confidential within the peer coaching relationship.
- It's important to note **this is not job coaching , it is not supervision and it is not employment counseling. It is not counseling at all.**



Peer to Peer Coaching

Anyone employed as Peer Recovery Support or Family Support Specialist is eligible for the program.

Peer/ Family Specialists access to “specially trained coaches “ for their own health and wellness needs.

This program offers health and wellness coaching and gives the peer workforce someone to they can turn to for additional support.

This is all made available through the Peer and Family Career Academy, at no charge, thanks to funding through AHCCCS and the State of Arizona!

Crisis Counseling Program

- AHCCCS awarded 90 Day No Cost Extension from FEMA and SAMHSA
- Performance period extended from 12/2/2022 to 3/2/2022
- Extension allows Resilient Arizona to continue provision of crisis counseling services for Arizona citizens

- Utilization of the CCP remains high across Arizona

ArMA Peer Physician Program/Doctor's Virtual Lounge

- Partnership between ADHS, AHCCCS and ArMA-program implemented in the fall of 2020
 - The lounge is an evidenced-based peer support program for Arizona physicians; participation is free and confidential
- Program has been approved to be extended for one more year with funding from ADHS
- Expansion of program will include:
 - Peer Support for Medical Students
 - Virtual Support
 - Psychological First Aid
 - Resiliency and healthy coping strategies
