#### **COVID-19 Information**

AHCCCS is responding to an outbreak of respiratory illness, called COVID-19, caused by a novel (new) coronavirus. Health officials urge good hand washing hygiene, covering coughs, and staying home if you are sick.

On March 11, Governor Doug Ducey issued a Declaration of Emergency 🗗 📆 and an Executive Order 🗗 regarding the COVID-19 outbreak in Arizona, and subsequent Executive Orders 🗗 with further administrative actions.

On March 17, 2020, AHCCCS submitted a request to the Centers for Medicare and Medicaid Services (CMS) to waive certain Medicaid and KidsCare requirements in order to ensure ongoing access to care over the course of the COVID-19 outbreak. As of March 23, AHCCCS has received federal approval to implement programmatic changes to help ensure access to health care for vulnerable Arizonans.

To address Medicaid-related questions from providers and contractors about COVID-19, AHCCCS has developed a list of Frequently Asked Questions Regarding Coronavirus Disease 2019 (COVID-19), updated regularly s more information becomes available.

#### **FAQ Example**

Question: Arizonans are understandably stressed and anxious right now. What mental health resources do you recommend?

**Answer:** AHCCCS covers a full array of behavioral health services for members, and crisis services are available to anyone in Arizona, regardless of insurance coverage. In addition, we have added behavioral health resources offered by the CDC and SAMHSA on the COVID-19 webpage.



#### AHCCCS COVID19: Current BH Resources Linked

The outbreak of coronavirus disease 2019 (COVID-19) may be stressful for people and communities. Fear and anxiety about a disease can be overwhelming and cause strong emotions in adults and children.

## Hospital/ED Data Received to Date: Evaluating Scope of Members awaiting BH level of care/services in order to be discharged

- AHCCCS has been receiving Medicaid specific data from Mike Boylan/Crisis Preparation and Recovery (CPR)
- CPR is contracted with:
  - a. Banner Health (all locations in Maricopa and Pinal)
  - b. Honor Health (all locations)
  - c. Steward Health (all locations)
  - d. Abrazo Health (all locations)
  - e. AZ Generals (all locations)
  - f. Mayo Hospital
  - g. Wickenburg
  - h. Dignity (Westgate and Glendale)
  - i. Phoenix Children's Hospital
  - j. Valleywise (MIHS all locations)



## Hospital/ED Data Received to Date: Evaluating Scope of Members awaiting BH level of care/services in order to be discharged/CPR

- Number of patients being seen in ED has dropped significantly
- Number of crisis interventions requested by hospitals has decreased significantly
- BH hospitals have quite a few empty beds, so ED patients are transferring quickly and hold times are shorter
- EDs are NOT testing patients for COVID unless they are symptomatic

### COVID19 BH Task Force: 4 Strategic Priorities

- 1. Implement efforts to increase resiliency amongst all Arizonans, with specific targeted strategies for populations at risk of/with behavioral health needs
- 2. Ensure access to crisis, outpatient, and other BH services/levels of care
- 3. Evaluate and enhance first responder and health care provider support services
- 4. Provide best practice resources for BH providers on how to minimize risk of COVID transmission



### Increase Resiliency of Arizonans

- 1. Address the needs of all Arizonans experiencing life changes due to COVID-19
- ADHS and ASU Center for Mindfulness, Compassion and Resilience-daily webinars for continuing mindfulness practice and support
- 1. Address the needs of school aged children and their families
- PAXIS Institute: PAX GBG and other efforts to support teachers
- BH in schools: leveraging telehealth, remaining socially connected while physically distancing
- 1. Address the needs of Arizonans experiencing loss during COVID-19
- Compassion and end of life support: HOV is offering bereavement webinars and tips to memorialize and celebrate loved ones
- 1. Suicide prevention: targeted efforts for at-risk groups-ADHS and AHCCCS partnership



## Ensure Access to Crisis, Outpatient, and other BH Services/Levels of Care

- 1. Maintain Statewide BH Crisis System with enhanced targeted approach to address concerns re COVID-19
- Addition of COVID-19 Hotline
- 1. Maintain access to outpatient BH services while physically distancing to limit the spread
- Expanded services available via telehealth/telephonically



## Evaluate and Enhance Support Services for First Responders and Health Care Providers

- 1. "For Doctors, By Doctors" group of psychiatrists staffing peer hotline for fellow physicians
- 2. Exploring application for FEMA's Crisis Counseling and Assistance and Training Program (CCP)



## Provide best practice resources for BH providers on how to minimize risk of COVID transmission

- 1. Disseminate ADHS and County resources
- 2. Disseminate BH specific resources
- Arizona specific developed protocol
- National resources including SAMHSA
