## **OUR AUTHORITY**

Created under state statute A.R.S. §§ 41-3803, the MHRC is a non-political, community-based committee. We provide independent oversight to protect the rights of persons who receive publicly funded behavioral health services within Maricopa County.

#### WHAT WE DO...

- protect the rights of persons who receive behavioral health services,
- **conduct** site visits to behavioral health care facilities,
- review incidents and accident reports, AHCCCS and RBHS findings regarding appeals and grievances,
- *express* concerns and *initiate* investigations and grievances to AHCCCS and the RBHA,
- review and provide feedback about Arizona Health Care Cost Containment System policies and procedures,
- make recommendations to AHCCCS and the RBHA regarding the quality of behavioral health services,
- assist clients identified as needing special assistance in filing a grievance,
- **receive** notices of fair hearings for all clients, and
- receive and review notices of unmet service needs for all clients.
