1. <u>Name of the Agency:</u> Arizona Health Care Cost Containment System (AHCCCS)

2. The topic of the public information notice:

AHCCCS Fee-For-Service (FFS) per diem rates for Nursing Facilities to be effective for dates of service on and after January 1, 2019.

3. The public information relating to the topic:

- a. This Notice describes proposed changes to the Arizona Health Care Cost Containment System (AHCCCS) Fee-For-Service (FFS) per diem rates for Nursing Facilities to be effective for dates of service on and after January 1, 2019 to address the increased labor costs resulting from the Arizona minimum wage increase and employee benefit provisions mandated by Proposition 206, and the Flagstaff minimum wage increase mandated by Proposition 414 and later amended through action of the Flagstaff City Council. The total change in FFS payments as a result of the proposed changes is an estimated increase of \$243,585 for the time period of January 1, 2019 through September 30, 2019.
- b. AHCCCS' Managed Care Organizations will be required to pass-through these rate increases effective with dates of service on and after January 1, 2019 to Nursing Facility providers.
