- 1. Name of the Agency: Arizona Health Care Cost Containment System (AHCCCS)
- **2.** The topic of the public information notice: AHCCCS Fee-For-Service (FFS) rates for designated fee schedules to be effective for dates of service beginning October 1, 2022.

3. The public information relating to the topic:

a. This Notice of Public Information describes changes to the Arizona Health Care Cost Containment System (AHCCCS) Fee-For-Service (FFS) rates to be effective October 1, 2022. The AHCCCS Administration is adding additional benefits for Chiropractic, Biomarkers, and Diabetes Self-Management Training. As a result, the following codes and rates will be effective 10/1/2022. The rates specified in this Notice are to assure that payments are consistent with efficiency, economy, and quality of care and are sufficient to enlist enough providers so that care and services are available at least to the extent that such care and services are available to the general population in the geographic area. The estimated increase in FFS payments as a result of the additional benefits is expected to be approximately \$1,090,200. More detailed information regarding the additional codes is included below.
