## Suspensions for Credible Allegations of Fraud

Since May 2023, AHCCCS has suspended payments to over 300 providers for credible allegations of fraud.

Current status	Number of Providers (since May 2023)
Payment suspension and open law enforcement case	257
Provider Quality of Care terminations	120
Provider moratorium application denials	277
Rescinded suspensions	45
Suspensions upheld at state fair hearing	27



## Number of Calls to Solari by Week



- Working with Tribes on a phasedown plan
  - 11/30 Last day for lodging
  - Looking into extending 211(press 7) line
  - 211 will continue to be a resource, post phasedown

## **ALTCS EPD Updates**

AHCCCS has extended the current Arizona Long Term Care System for Elderly and/or Physically Disabled (ALTCS-EPD) Contracts with Banner-University Family Care, Mercy Care, and UnitedHealthcare Community Plan for one year, through September 30, 2025. This follows the recent Director's Decision to deny the appeal of the EPD award protesters.

## The Why behind Advance Directives



30-35% of Americans have an advance directive



HOSPITAL 70% prefer to die at home; 76% die in an institution



50% of patients are unable to participate in healthcare decisions when the time comes to make them



90% of people say talking with loved ones about their healthcare is important; only 27% have done so





## **CHALLENGE**

It is always too early until it is too late.





#### The What - Advance Directive Documents

- The AzHDR will accept healthcare directives submitted in compliance with Arizona Healthcare Directives Law (ARS 36-2301-3287), including:
  - Living Will
  - Health Care Power of Attorney
  - o Mental Health Care Power of Attorney
  - Prehospital Medical Care Directives (DNR/Orange Form)
- Additional focus on incorporating other documents into the registry that are part of the advance care planning (ACP) continuum, include but are not limited to the POLST, organ donation and HIPPA documents.

Advance directives are documents of **choice** and not of limitation. Identifying these documents as such opens the landscape to a wider patient population, while enhancing health **equity**.



## The What – Arizona Healthcare Directives Registry (AzHDR)

- Contexture operates the Arizona Healthcare Directives Registry (AzHDR), a platform that allows healthcare providers seamless access to patients' advance directive documents.
- The registry stores and makes viewable advance directive documents, including:
  - Living Wills
  - Healthcare Power of Attorney
  - Mental Healthcare Power of Attorney
  - Pre-Hospital Medical Care Directive (Out of Hospital Do Not Resuscitate (DNR Orange form))
- In November 2021, the Secretary of State transferred to Contexture advance directive documents that were held in their portal.
  - Registered accounts in AzHDR has increased 41% since that time.
- The AzHDR is available to consumers and providers across Arizona.
- There is no cost to participate, and providers do not have to be participating with other Contexture programs.







**Healthcare Providers** can search, view and upload documents



**Legal and Financial Organizations** can upload documents




**Community Based Organizations** can upload documents

- To participate, providers will complete simple paperwork
- Onboarding training is provided
- Additional staff training on advance care planning and advance directives is available
- AzHDR staff can participate in organizational and community events

Since moving the registry to Contexture, we have increased provider participation by 400%.

## The Who – You are never too young or healthy for advance directive documents

- Advance care planning is essential for everyone, regardless of age or health status.
- Completing advance directives prepares you for future medical decisions, especially when you are not able to communicate your wishes.
- Having an advance care plan ensures your medical preferences are known and followed.
- Choosing "your person" ensures that the individual who is making decisions on your behalf aligns with your wishes and is the person(s) who you want to be your voice.
- Advance directives can help loved ones grieve more easily and feel less burden or guilt over decisions that have been made.







- Diagnosed with a chronic health condition, or
- Currently in correctional facility with a release date scheduled within 90 days or released from a correctional facility within the last 90 days.



## Former Foster Youth Eligibility and Enrollment - Amendment Request

- Waive the condition of eligibility in 42 CFR 435.608 requiring Medicaid beneficiaries to apply for other cash benefits for the Former Foster Youth (FFY) population.
- Relieve individuals who meet the statutory definition at 1902(a)(10)(A)(i)(IX) of the obligation to provide information about potentially liable third parties at renewal as a condition of eligibility.
- Extend eligibility for Medicaid state plan benefits to FFY who are under age 26, who turned 18 on or before December 31, 2022, who were in foster care under the responsibility of another state or tribe on the date of attaining 18 years of age, were enrolled in Medicaid on the date of aging out of foster care, and are now applying for Medicaid in Arizona.



## Former Foster Youth Eligibility and Enrollment - Current Program Overview

- Eligible Group: Youth who age out of foster care and are on Medicaid when they reach the age of majority.
- Eligibility Period: After aging out of care until reaching 26 years of age.
- Eligibility Requirements: AZ resident, identify and take action needed to get payments from TPL sources and cooperate with child support enforcement.
- This is otherwise known as the 'Young Adult Transitional Insurance (YATI)' group.



# Former Foster Youth Eligibility and Enrollment: What is changing?

- The original request is in alignment with House Bill 2622 passed by Arizona's 55th Legislature
- Maintaining and extending eligibility: Eligibility will be automatically renewed without requiring additional information from the individual until the individual reaches 26 years of age.
   Provides eligibility under YATI for youth who aged out of care in other states before December 31, 2022.
- Effective Date: Effective upon CMS approval and completion of necessary operational and system modifications.



# Former Foster Youth Eligibility and Enrollment-Eligibility Limitations

#### Coverage may end if:

- The individual reaches 26 years of age,
- The individual ceases to be a resident of the state,
- AHCCCS determines that eligibility was determined incorrectly because of agency error or fraud, abuse or perjury attributed to the individual, or
- The individual dies.



# Former Foster Youth Eligibility and Enrollment - Future Steps

Upon CMS approval, the following operational and system modifications will be implemented:

- 1. System programming to stop generating requests for information related to TPL Policy revisions,
- 2. Training updates and staff training on policy change, and
- 3. Develop and deploy communication plan.

## New SMAC Member Spotlight - Dr. Aaron Knudson

Dr. Aaron Knudson has been an Internal Medicine and Pediatric Hospitalist at Banner Health Page Hospital for the last 6 years and is the former Chief of Staff and Facility Medical Director through the Covid-19 National Health Emergency. He has also been foundational in organizing and opening Creek Valley Health Clinic in 2019. A Federally Qualified Health Center in Colorado City, Creek Valley provided a medical home for residents that had no local access to primary care for over 10 years. He was first provider seeing patients when Creek Valley opened its doors and now the board president focusing on patient advocacy. Dr. Knudson also opened Banner Health's primary care clinic in Page Arizona in 2012 operating as a primary care provider for 6 years growing the clinic to 4 providers. Dr. Knudson is also a Clinical instructor for the University of Arizona's Longitudinal Integrated Clerkships, providing a rural health experience with an emphasis on continuity of care and the benefits of practicing rural medicine. He is originally from a small northern Arizona community, seeing the limited healthcare resources in the region inspired to become a physician. Dr. Knudson has also completed a combined Internal Medicine and Pediatric Residency at Pennsylvania State University in 2012.

Terry Benelli, Executive Director of LISC Phoenix believes comprehensive community development is not possible without targeted investments. She is dedicated to ensuring residents of marginalized neighborhoods acquire assets they desire for upward mobility — jobs, safe and stable housing and communities designed to promote health.

Terry oversees the community development operation of LISC Phoenix. She is a Fellow of the Flinn Brown Civic Leadership Institute and a Board member of Urban Land Institute- Arizona, Board member of the San Francisco Federal Reserve Bank and past City Councilperson for the City of Mesa.


