Agency Successes: 2023 in Review

2023: Year in Review

- Renewed eligibility for more than 1.2 million AHCCCS members and deployed Arizona's 12-month strategic plan to ensure a smooth return to regular renewal process,
- Addressed organized, fraudulent Medicaid behavioral health billing with numerous operational and administrative system changes to strengthen program security,
- Launched the Arizona Perinatal Access Line and Targeted Investments 2.0 program,
- Partnered with Arizona's community colleges, Association of Training & Development, PipelineAZ, Arizona Board of Nursing, and Arizona Hospital and Healthcare Association to launch workforce development programs to address future health care worker needs,
- Created a new Olmstead Plan outlining the agency's priorities regarding members at risk of institutionalization,
- Continued implementation planning for the Housing and Health Opportunities (H2O) program,

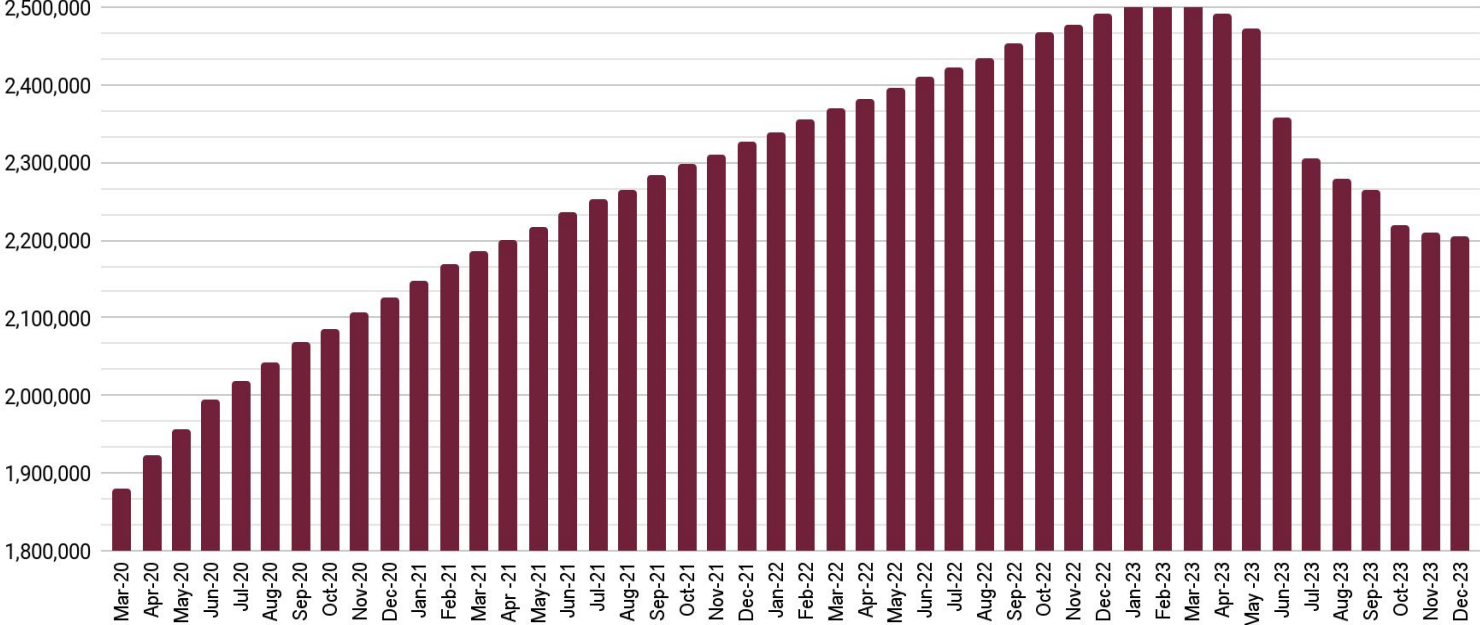
2023: Year in Review

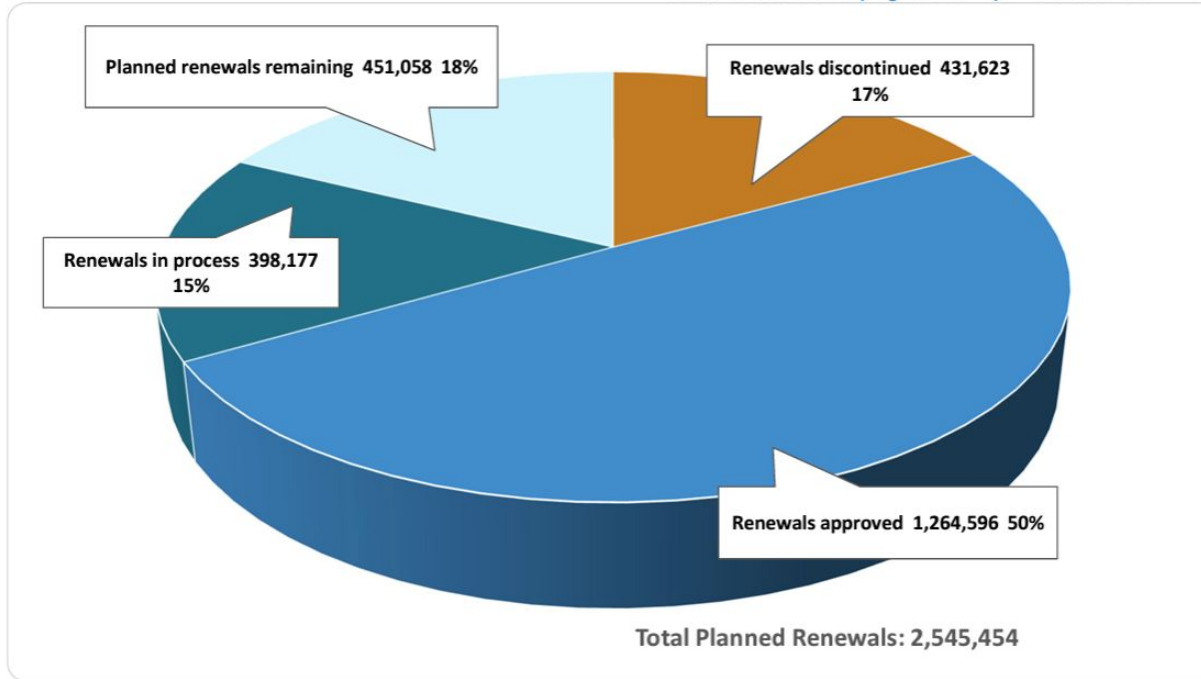
- Reformed the agency's Tribal Consultation process to allow for greater input from tribal leaders and governments,
- Reformed Peer Support Training Programs to incorporate national standards,
- Awarded \$17 million to more than 60 Home and Community Based Services (HCBS) providers, and disseminated \$368.23 million of American Rescue Plan funding through MCOs to 3,930 HCBS organizations,
- Extended coverage to women for up to 12 months postpartum,
- Submitted an 1115 waiver amendment to expand Kidscare eligibility to 225% FPL,
- Allowed for Certified Community Health Workers and Community Health Representatives to be reimbursed for AHCCCS covered services,
- ... and many more!

Fraudulent Billing and Member Exploitation

Update on High-Risk Provider Type/ Moratoria Extension

Moratorium Exemption Requests

- On June 9, 2023, AHCCCS implemented a temporary (6 month) provider moratorium on 5 provider types (77, B8, IC, NEMT and CSA).
- On November 9, 2023, AHCCCS submitted a request to extend the moratorium to CMS.
- On December 6, 2023, AHCCCS received approval for a 6 month extension on the current moratoria.
 - The new expiration date will be June 9, 2024.

High-Risk Provider Types

1. Behavioral Health Residential Facility (B8)
2. Integrated Clinics (IC)
3. Behavioral Health Outpatient Clinics (77)
4. Non-Emergency Medical Transport (28)

What providers need to know:

At initial application and at revalidation, need to pay application fee and meet additional requirements:

- Fingerprint-Based Criminal Background Check (FCBC)
 - o Individual high-risk providers (such as individual Non-Emergency Medical Transportation providers),
 - o Owners of high-risk provider types,
 - o A person with a 5 percent or more direct or indirect ownership interest in a high-risk provider, and
 - o All Statutory Agents and Directors, Executive Directors, Chief Executive Officers, and Presidents listed publicly on the Arizona Corporation Commission Entity Information page under the Principal Information Section.
- Site visit in accordance with Section 6401 of the Affordable Care Act and 42 CFR 455, Subpart E, in addition to all other required screenings.

COMING JANUARY 4, 2024!

Beginning January 4, 2024, AHCCCS will require proof of Identity in order to continue using the AHCCCS Online website. In addition to having a website account, all users will be required to have an *ID.me* account. *ID.me* is our federally certified technology partner for secure digital identity verification.

Whether or not you already have an *ID.me* account, no further action is necessary at this time. On or after January 4, 2024, when you login to AHCCCS Online, you will also be required to login to an existing *ID.me* account, or create a new account. In either case, *ID.me* requires your consent to share your personal information with AHCCCS in order to complete the verification process. In order to continue using the AHCCCS Online website, the information on your AHCCCS Online account must match the information on your *ID.me* profile.

 - o EFT/Direct Deposit - Phased rollout to start in January; providers who currently receive paper checks directly from AHCCCS will be contacted with how to enroll in EFT and provided 30 days notice to switch to direct deposit
- Clarifying requirements to serve AIHP members
 - o “The Provider shall not decline to provide health care services for any AHCCCS eligible and enrolled member due to such member’s health plan.”

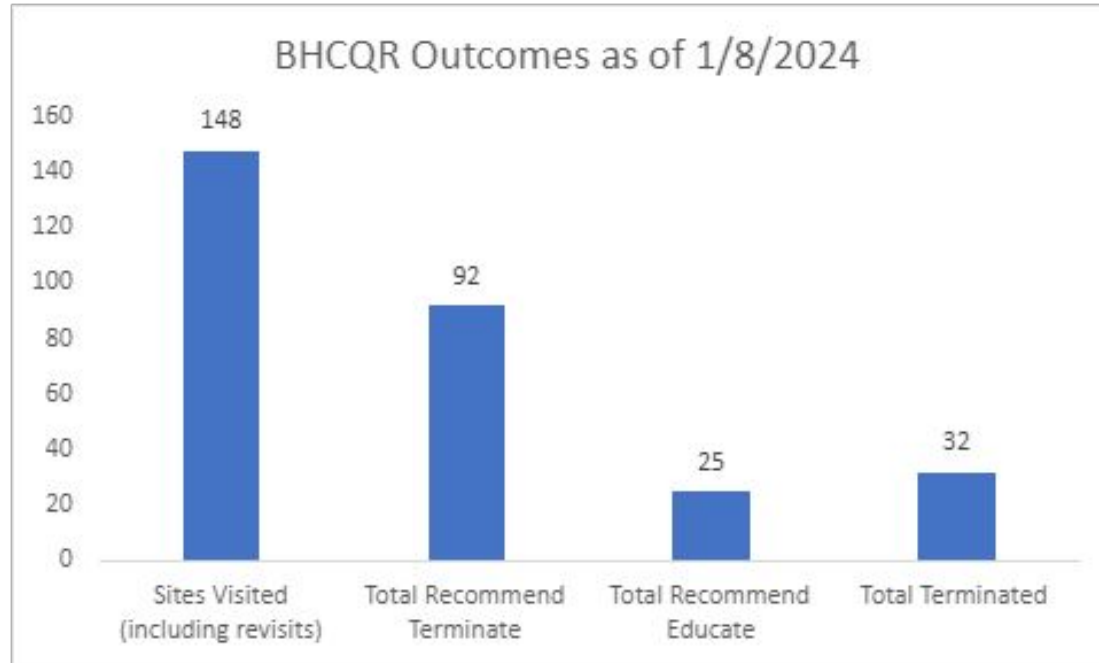

DFSM Updates

Transforming the Fee-for-Service Program into a quality of care-focused program

- Increase proactive quality assurance on-site visits to FFS providers
- Increase Medical Management team to review provider documentation, utilization management functions, and assist with on-site visits
- Enhanced collaboration with Office of Data Analytics to ensure data driven strategies

DFSM Behavioral Health Clinical Quality Reviews



ROPA

- Per 42 CFR 455.410 of the Affordable Care Act, the State Medicaid Agency must require all ordering or referring physicians, or other professionals providing services to be enrolled as participating providers.
- This means that referring, ordering, prescribing and attending (ROPA) providers must be AHCCCS-registered providers to ensure payment of items or/or services
 - Implementation for FFS only, and will start with rendering, ordering and attending providers
- AHCCCS has extended the ROPA registration deadline to 7/1/2024

Pharmacy ROPA

Since pharmacists may act as the prescribers for immunizations administered in the pharmacy, AHCCCS created a flexibility that will allow AHCCCS to capture the required data in the system for claims payment, without requiring pharmacists to enroll a participating providers.

- Initial lists with the needed data were collected from IHS/638 pharmacies and were included in the ROPA Excepted Providers List.
- To update or be added to the excepted list, pharmacists, residents, and interns must submit the following information to: ROPAExceptions@azahcccs.gov
 - NPI
 - Provider Name
 - INDication of whether the NPI is associated with a resident, intern, or pharmacist, and
 - The beginning date associated with the associations.

AHCCCS Federal Policy Overview

AHCCCS' Federal Relations team maintains the two federal policy documents which govern Medicaid and CHIP in Arizona:

1. **State Plan:** A 900+ page document describing various components of AHCCCS (e.g. member eligibility, available services, payment rates) permissible under federal law.
2. **1115 Waiver:** A document which grants us flexibility to design Demonstration projects that promote the objectives of the Medicaid program not otherwise authorized under federal law.

Changes to AHCCCS Federal Policy

Changes to AHCCCS Federal Policy occur through:

1. **State Plan Amendments (SPAs)**: SPAs may be used to alter the State Plan within the framework of federal law and are typically approved within 90-days.
2. **1115 Amendment Requests** may be submitted to pilot new and innovative projects. They have longer negotiation timelines and are typically approved for 5 year periods that can be renewed.

Status of Submitted 1115 Waiver Amendments

KidsCare Expansion to 225% FPL

- Submitted to CMS November 15, 2023.
- AHCCCS gathered public comments in December 2023.

Parents as Paid Caregivers (PPCG)

- Proposal submitted to CMS September 27, 2023.
- Negotiations underway with CMS

Former Foster Youth Automatic Renewal (YATI)

- Submitted to CMS March, 2023
- Currently undergoing negotiations with CMS.

Status of Submitted 1115 Waiver Amendments

Traditional Healing

- Negotiations re-initiated with CMS July 2023.
- TH workgroup helped in answering a variety of CMS questions on services, providers, eligibility, and more.
- Now awaiting additional guidance from CMS on next steps.

Pre-Release Services

- Proposal to offer a set of pre-release services to incarcerated individuals a certain number of days prior to release.
- In final stages of finalizing a concept paper detailing the updated the proposal.
- Currently evaluating the cost of the update concept paper

Status of Other 1115 Waiver Activities

Housing and Health Opportunities (H2O)

- Implementation work has continued for targeted go live date of October 1, 2024.
- Information gathering phase for an RFP for H2O-PA

Waiver Evaluation

- Activities underway with Independent Evaluator, HSAG.
- Evaluation Design for all Waiver Programs due to CMS on January 31, 2024.

Upcoming State Plan Amendments (SPAs)

Medicaid Children's Continuous Eligibility

- This SPA establishes 12-months of Medicaid continuous eligibility for children. It is a requirement of Section 5112 of the Consolidated Appropriations Act (2023).

CHIP Vaccine Coverage

- This SPA confirms that Arizona provides coverage and payment of vaccines recommended by the Advisory Committee on Immunization Practices (ACIP) and their administration without cost sharing to members.

Upcoming State Plan Amendments (SPAs)

Medicaid and Chip Core Set Reporting

- This SPA attests to Arizona's compliance with federal requirements for mandatory Medicaid and CHIP Core Set Reporting that were established in Final Rule 88 FR 60278.

BYLAWS FOR THE A.H.C.C.C.S STATE MEDICAID ADVISORY COMMITTEE (SMAC)

MISSION

The SMAC will participate in the development of policy and program administration for the Arizona Health Care Cost Containment System (AHCCCS). Participation will include review of policy, rules, and administrative issues for applicable AHCCCS programs. The SMAC will advise the AHCCCS Director on policy and administrative issues of concern to the SMAC member constituency.

To facilitate accomplishing its mission, the SMAC will, whenever practicable, recommend issues, and/or policies for inclusion on the SMAC agenda in order to allow for consideration prior to recommendation and possible implementation by the AHCCCS. SMAC membership may also request background information and/or policy papers in advance of SMAC meetings, allowing for a deliberative discussion of the issues with AHCCCS Senior Management during the SMAC meeting.

AUTHORITY

The SMAC operates in accordance with 42 CFR 431.12 and the Arizona State Medicaid Plan.

DEFINITIONS

“AHCCCS” or “Administration” means the Arizona Health Care Cost Containment System as defined in Arizona Revised Statutes (A.R.S.) §§ 36-2901, -2931, -2971 and -2981.

“SMAC” means the State Medicaid Advisory Committee, as appointed by the AHCCCS Director.

“AHCCCS Director” means the Director of AHCCCS as specified in A.R.S. §§ 36-2901, -2931, -2971 and -2981.

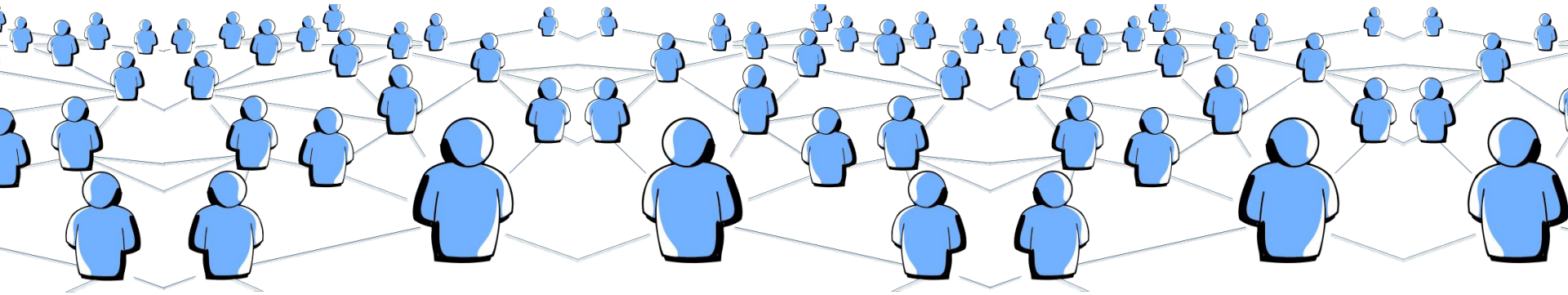
