- Cover page for Application for Benefits
 - o The group agreed using the Washington State applications as cover pages to be used by the Tribes when submitting the Application for Benefits. The application will be revised as needed and will be maintained by AHCCCS. Julie (AHCCCS) will draft language instructions for the forms. It is expected that the use of the cover pages will expedite the Medicaid application process for youth in foster care under Tribal jurisdiction.
