






### Overview of State Plan/ State Plan Amendments (SPAs)

- Each state has a Medicaid state plan that describes how the state will administer its Medicaid program.
- States must follow broad federal rules in order to receive federal matching funds, but have flexibility to design their own version of Medicaid within the federal statute's basic framework.
- In order to alter a State Plan, states must submit State Plan Amendments (SPAs), and receive approval from CMS.



#### **Timeline - SPA Processing**



Continuous Enrollment requirement still in effect until the federal COVID-19 PHE ends



### Existing Postpartum Coverage (Prior to Coverage Extension)

AHCCCS currently offers 60-days of postpartum coverage, beginning on the last day of the pregnancy.

- Eligible Group: Pregnant women who were eligible and enrolled under the state plan.
- Coverage is regardless of any changes in income that would otherwise result in ineligibility.



### Postpartum Coverage Extension: Key Provisions

• Benefit Description:

12-months of continuous eligibility to pregnant individuals who were eligible and enrolled under the state plan while pregnant (including during a period of retroactive eligibility).

- Benefit Details: Services are not less in amount, duration or scope than what is already covered under the state plan.
- Benefit Effective Dates: This will be effective upon CMS approval AND the completion of all AHCCCS operational/system modifications. The coverage extension ends on March 31, 2027



### Postpartum Coverage Extension: Key Provisions

- Coverage Period: The The 12-month postpartum period begins on the last day of a beneficiary's pregnancy (including a members retroactive coverage period) and extends through the end of the month in which the 12-month period ends.
- Eligible Individuals: Women who were eligible and enrolled under the Medicaid state plan while pregnant, including during a period of retroactive eligibility.
- This extension does not apply to individuals eligible only during a period of presumptive eligibility.



### Postpartum Coverage Extension: Key Provisions (Cont'd)

• Similar to the current 60-day postpartum period, under the extended postpartum coverage option, individuals are entitled to the extended postpartum coverage regardless of the reason the pregnancy ends.



### Postpartum Coverage Extension Key Provisions

Coverage may end if:

- The individual voluntarily terminates their coverage
- The individual ceases to be a resident of the state
- AHCCCS determines that eligibility was determined incorrectly because of agency error or fraud, abuse or perjury attributed to the individual
- The individual dies



#### Postpartum Coverage - Next Steps

Operational and system modifications:

- 1. System programming to accommodate the extended PP timeframe;
- 2. Policy, forms and letter revisions;
- 3. Training material updates and staff training on changes to PP coverage;
- 4. Identify and update members whose pregnancy ended before program implementation, but are still within the 12-month PP period;
- 5. Develop and deploy Communication Plan.


