






Crisis Services – HP Self Reported




Rapid Response – HP Self-Reported (72-Hour Requirement)




TFC Utilization by Avg. Length of Stay – AHCCCS Calculated Preliminary




TFC Utilization – AHCCCS Calculated




Respite Utilization – AHCCCS Calculated




Grievances – HP Self-Reported



ACOM 449 – Liaison & After-Hours Call Volume – HP Self-Reported




AHCCCS Clinical Resolutions – Jacob’s Law Call Volume¹


Behavioral Health Enrolled Served¹
