



Category of service is the description of the types of services rendered at a provider type level. Each provider type has certain categories of service available. Some are mandatory and others are optional. Mandatory categories of service are automatically assigned at a provider level and require licensure or certification. Optional categories of service can be added at a provider type level and may require licensure or certification. Optional categories can be added by submitting a ticket.

Submit a ticket by email to <u>APEPTrainingQuestions@azahcccs.gov</u> with the subject "Add a Category of Service for Provider." Include proof of licensure or certification if required for the category of service being added. The body of the email must include:

- a. Provider's Name,
- b. Provider's AHCCCS ID,
- c. Provider's Tax ID,
- d. Provider's NPI, if applicable, and
- e. A copy of the license or certification to support the requested category of service, if applicable.

If you do not include *all* the information listed above the ticket will be closed. You will need to submit a new, complete ticket to request the category of service be added.

Listed below are the categories of service with licensure or certifications that may be required. Not all licensure or certifications listed will be required. Not all categories of service are available to all provider types. AHCCCS will provide more information about the categories of service available to each provider type at a later date.
