CMS Scorecard Measures

The State Health System Performance measures show how states serve Medicaid and CHIP beneficiaries in six areas:

- Promoting communication & care coordination
- Reducing harm in care delivery
- Promoting prevention & treatment of chronic diseases
- Strengthening engagement in care
- Making care affordable
- Working with communities to promote healthy living



Quality Rating System

CMS, in consultation with States and other stakeholders and after providing public notice and opportunity to comment, will identify performance measures and a methodology for a Medicaid managed care quality rating system that aligns with the summary indicators of the qualified health plan quality rating system developed per 45 CFR 156.1120.

Primary Care Access and Preventative Care

- 1. Cervical cancer screening (NCQA)
- 2. Chlamydia Screening women 21-24 (NCQA)
- 3. Flu Vaccinations for Adults 18-64 (NCQA)
- 4. Screening for Depression and Follow-Up Plan age 18 and older (CMS)
- Breast cancer screening (NCQA)
- 6. Adult Body Mass Index Assessment (NCQA)



Maternal and Perinatal Health

- 1. Elective Delivery (TJC)
- Prenatal and Postpartum Care: Postpartum Care (NCQA)
- 3. Contraceptive Care-Postpartum women ages 21-44 (OPA)
- 4. Contraceptive Care-All Women ages 21-44 (OPA)



Care of Acute and Chronic Conditions

- 1. Controlling High Blood Pressure (NCQA)
- 2. Comprehensive Diabetes Care: HbA1c Testing (NCQA)
- Comprehensive Diabetes Care: HbA1c poor control (>9%)
- 4. Diabetes Short Term Complications Admission Rate (AHRQ)

Behavioral Health Care

- 1. Initiation and Engagement of Alcohol and Other Drug Abuse or Dependence Treatment (NCQA)
- 2. Medical Assistance with Smoking and Tobacco Use Cessation (NCQA)
- 3. Antidepressant Medication Management (NCQA)
- 4. Follow up after hospitalization for Mental Illness: 18 and older (NCQA)
- 5. Diabetes Screening for People with Schizophrenia or Bipolar Disorder who are using antipsychotic medications (NCQA)
- 6. Follow up after ED visit for alcohol and other drug abuse or dependence (NCQA)
- 7. Follow up after ED visit for mental illness (NCQA)
- 8. Diabetes care for people with SMI: HgBA1c poor control (>9%) (NCQA)
- 9. Use of Opioids at high dosage in persons without cancer (PQA)
- 10. Adherence to antipsychotic medications for individuals with schizophrenia (NCQA)
- 11. Concurrent use of benzos and opioids (PQA)
- **12.** Use of pharmacotherapy for OUD (CMS)

Primary Care Access and Preventative Care

- 1. Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents-BMI Assessment for Children Adolescents (NCQA)
- 2. Chlamydia screening in women ages 16-20
- 3. Childhood immunization status (NCQA)
- 4. Screening for Depression and follow up plan: ages 12-17 (CMS)
- 5. Well-child visits in the first 15 months of life (NCQA)
- 6. Immunizations for adolescents (NCQA)
- 7. Developmental screening in first three years of life (OHSU)
- 8. Well child visits in third, fourth, fifth and sixth years of life (NCQA)
- Adolescent well-care visits (NCQA)
- 10. Children and adolescents access to PCPs (NCQA)



2020 Child Core Set (DRAFT)

Maternal and Perinatal Health

- 1. Pediatric Central Line Associated Bloodstream Infections (CDC)
- 2. Cesarean Birth (TJC)
- 3. Audiological Diagnosis no Later than 3 months of age (CDC)
- 4. Live Births weighing less than 2500 grams (CDC)
- 5. Prenatal and Postpartum care: timeliness of prenatal care (NCQA)
- 6. Contraceptive care—postpartum women ages 15-20 (OPA)
- 7. Contraceptive care—all women ages 15-20 (OPA)

Care of Acute and Chronic Conditions

- 1. Asthma Medication Ratio: Ages 5-18 (NCQA)
- 2. Appropriate Antibiotic Prophylaxis for Children with Sickle Cell Anemia (Q-METRIC)
- 3. Ambulatory Care: ED Visits (NCQA)

Behavioral Health Care

- Follow Up Care for Children Prescribed ADHD Meds (NCQA)
- Follow up after hosp. for mental illness ages 6-17 (NCQA)
- Use of first line psychosocial care for children and adolescents on antipsychotics (NCQA)
- 4. Metabolic monitoring for children and adolescents on antipsychotics (NCQA)
- Use of multiple concurrent antipsychotics in children and adolescents (NCQA)

Dental and Oral Health Services

- 1. Dental Sealants for 6-9 year old children at Elevated Caries Risk (ADA)
- 2. Percentage of Eligibles who received preventive dental services (CMS)

MCO calculates and reports PMs with validation procedures by AHCCCS EQRO (HSAG) per 42 CFR Part 438, subpart E

§438.362 Exemption from external quality review



OPTION 2

 AHCCCS calculates MCO PMs rates through Changehealth product compliance reporter with validation by EQRO
