This question is a little more specific regarding claims and encounters. For example, if a cycle 1 claims submission was incorrect and AHCCCS indicated the correct answer in its response, can an MCO correct the corresponding encounters submission? Were the MCO do to so, the encounter would no longer exactly match what was submitted for the claim. We are seeking clarity to ensure that if we make such a correction that the encounter would not be counted in error on the basis it did not match the claim (even if it did match AHCCCS' communicated correct answer for the claim.)
