# Key Concepts



---

Working through the Managed Care Organization(s) (MCO) practices/sites are expected to utilize community based resource and practice knowledge to enhance relationships and create protocols for when to refer members to those resources.

At a minimum practices/sites should establish relationships with:

1. Community based social service agencies
2. Self-help referral connections
3. Substance misuse treatment support services
4. When age appropriate, schools and family support services

# TI Year 2 Measurement Period

October 1, 2017 – September 30, 2018

## **Practice Reporting Requirement to State:**

**By September 30, 2018** identify the sources for the practice's list of community-based resources

**AND**

**By September 30, 2018** identify the agencies and community-based organizations to which the practice has actively outreached and shows evidence of establishing a procedure for referring members that is agreed upon by both the practice and the community based resource.

# Attestation and Document Validation

- AHCCCS will be opening a TI Attestation Portal through **AHCCCS Online**  
(<https://azweb.statemedicaid.us/Account/Login.aspx?ReturnUrl=%2f>)
- The portal will be available for milestone attestation in June 2018.
- Not all of the Milestones will require providers to upload documentation through the Attestation Portal for review by AHCCCS.
- In order to attest to meeting this Core Component, participants will need to identify the sources for the practice(s) list(s) and identify who they have outreached to and established a procedure for referral.
- More detailed information and guidance about how to use the TI Attestation Portal will be available prior to June 2018.

Document that the practice has conducted member and family experience surveys specifically geared toward evaluating the success of referral relationships and that the information obtained from the surveys is used to improve the referral relationships.
