## Core Component #14 for Justice Area of Concentration

**Develop an outreach plan to encourage medium to high criminogenic risk pre and post release members to utilize an established integrated clinic.**

# Key Concepts

---

- The outreach plan should target pre-release and post-release teams to utilize the established clinic to ensure there is care coordination between care that was provided in jails and prisons to care that needs to occur in established clinic(s).
- The plan should be developed and implemented in cooperation with the probation and/or DOC parole office (s) that targets the individuals with medium to high criminogenic risk.
- Procedures will need to be developed to ensure that the practices can identify and provide Medicaid eligibility and enrollment support to individuals transition to probation and or DOC parole offices.

# TI Year 2 Measurement Period

October 1, 2017 – September 30, 2018

**Practice requirement to the state:**

**By September 30, 2018:**

**Wave 1:**

**A. By September 30, 2018** Document that the practice has developed and implemented an outreach plan in cooperation with the probation and/or DOC parole office(s) that specifically targets individuals with medium to high criminogenic risk.

**AND**

**B. By September 30, 2018** Document that the practice procedures for identifying and providing Medicaid eligibility and enrollment support to individuals transitioning to probation and/or DOC parole offices.

# Attestation and Document Validation

- AHCCCS will be opening a TI Attestation Portal through **AHCCCS Online**(<https://azweb.statemedicaid.us/Account/Login.aspx?ReturnUrl=%2f>)
- The portal will be available for milestone attestation and document upload in June 2018
- Not all of the Milestones will require providers to upload documentation through the Attestation Portal for review by AHCCCS.
- In order to attest to meeting this Core Component, participants will need to attest that they have an outreach plan and can document procedures.
- More detailed information and guidance about how to use the TI Attestation Portal will be available prior to June 2018.

# Sneak Peek: TI Year 3 Measurement Period October 1, 2018 – September 30, 2019

## Practice Reporting Requirement to the State:

**Wave 2: By March 31, 2019,** Document that the practice has developed and implemented an outreach plan in cooperation with the probation and/or DOC parole office(s) that specifically targets individuals with medium to high criminogenic risk.

### **Waves 1 and 2- By September 30, 2019:**

- A. Document practice procedures for identifying and providing eligibility and enrollment support to individuals transitioning to probation and/or DOC parole offices, **AND**
- B. Document that the practice has a means for obtaining and analyzing at least semi-annually the member experience of those members who have visited the clinic, and those who have not yet still visit the associated probation/parole office, **AND**
- C. Document that the practice has developed and implemented changes in its outreach plan in response to member experience, to attain higher utilization of practice services among those on probation/parole who travel to the probation or parole office per the terms of their release.
