THE ABOVE REFERENCED CONTRACT IS HEREBY AMENDED AS FOLLOWS:  <p>➤ <b>Section D, Program Requirements</b></p> <p><b>Paragraph 50, Compensation - Delivery System and Provider Payment Initiatives</b> <b>Add the following:</b></p> <p><u>Effective October 1, 2020, AHCCCS seeks to provide enhanced support to Home and Community Based Services (HCBS) and Rehabilitation providers in order to support direct care workers and enhance, expand, or strengthen home and community-based services through a lump sum directed payment methodology. AHCCCS will compute the increase and will make available to the Contractor the associated amounts of payments owed to providers. The Contractor will be paid outside of the monthly capitation payments through a single separate payment. Federal regulation mandates that these payments be prior-approved by CMS before they shall be implemented. AHCCCS will notify the Contractor when CMS approves the HCBS directed payment.</u></p>
