Section 9010 of the Patient Protection and Affordable Care Act (ACA) requires that the Contractor pay a Hea
Insurer Assessment Fee (HIF) annually based on its respective market share of premium revenue from the preced
year (calendar year 2013 revenue). AHCCCS provides funding to the Contractor for the Health Insurer Assessment F
and associated taxes subject to receipt and review of documentation from the Contractor as required by AHCCCS.
Capitation rates were previously amended for the month of October, 2013 to account for the 2014 Health Insu
Assessment Fee inclusive of federal and state income taxes. This contract amendment serves to retroactively adj
the October, 2013 capitation rates to include the federal and state income taxes associated with the 2014 Hea
Insurer Assessment Fee, and amends the following sections of the contract:
