What Are Social Determinants of Health

- Social Determinants of Health are the conditions in which a person is born into, grows, lives, works and ages that impact their health.
- Social Determinants of Health take into account factors such as the member's education, employment, physical environment, socioeconomic status, and social support network.



Why Are Social Determinants of Health Important

Social Determinants of Health are important because they allow providers to offer the best possible care to members as it allows them to identify things such as:

- Illiteracy
- Unemployment
- Lack of adequate food and safe drinking water
- Social exclusion and rejection
- Homelessness, substance use disorders, and
- Many other factors which may affect a member's overall health and well-being.

Thus, ICD-10 codes have been created to delineate these social determinants.



- AHCCCS began to monitor for the presence of Social Determinants of Health ICD-10 codes on April 1, 2018.
- Any Social Determinant of Health ICD-10 diagnosis codes which are identified by the provider should also be submitted on the claim for an AHCCCS member, in order to comply with state and federal coding requirements.



- Please note that Social Determinants of Health codes are <u>NOT</u> to be used as primary ICD-10 diagnosis codes.
- Social Determinants of Health shall <u>not</u> be listed as the primary diagnosis on the claim form, and should instead be listed secondary, tertiary, etc., ICD-10 codes.



- If a social determinant ICD-10 code is listed as the primary diagnosis code on a claim, then the claim may deny.
 - ☐ Providers should follow National Coding Standards.
- Please also note that the list of Social Determinants of Health codes may be added to or updated on a quarterly basis.
 Providers should remain current in their use of these codes.
- The list posted on the AHCCCS website is not an all-inclusive list and is meant to provide only a small subset of examples.



Examples of Social Determinants of Health

Here are a couple of examples of how providers can use the Social Determinants of Health codes. Please note again that a medical or behavioral health ICD-10 code <u>must</u> be used as the primary diagnosis.

Example 1:

A provider renders service to a member who is diagnosed with lung disease. The member is currently homeless and will have a hard time affording medication. The claim may be submitted with a primary diagnosis of lung disease, and then the identified Social Determinants of Health would be listed as secondary and tertiary diagnoses.

Secondary Diagnosis: Social Determinant of Health-Homelessness (using ICD-10 code Z590)

Tertiary Diagnosis: Social Determinant of Health-Extreme Poverty (using ICD-10 code Z595)



Examples of Social Determinants of Health

Example 2:

A provider sees a member for asthma, and it has been determined that the member lives in an environment that has a lot of dust in the air. It has also been determined that the member has a low level of literacy, which may prevent the member from being able to read and follow their care plan and their prescription medication directions precisely. The claim may be submitted with a primary diagnosis of asthma, and then the identified Social Determinants of Health would be listed as secondary and tertiary and quaternary diagnoses.

Secondary Diagnosis: Social Determinant of Health-Occupational Exposure to Dust (using ICD-10 code Z572)

Tertiary Diagnosis: Social Determinant of Health-Occupational Exposure to Other Air Contaminants (using ICD-10 code Z5739)

Quaternary Diagnosis: Social Determinant of Health-Illiteracy and Low-Level Literacy (using ICD-10 code Z550)



Examples of Social Determinants of Health

Example 3:

A provider renders service to a member who is diagnosed with cancer. The member has indicated that they have been exposed to radiation over many years from their job. The claim may be submitted with a primary diagnosis of cancer, and then the identified Social Determinant of Health would be listed as a secondary diagnosis.

Secondary Diagnosis: Social Determinant of Health-Occupational Exposure to Radiation (using ICD-10 code Z571)

- How to submit and status claims or prior authorization requests through the AHCCCS Online Provider Portal (FFS programs, including AIHP, TRBHAs and Tribal ALTCS).
- Submission of documentation using the Transaction Insight Portal (i.e. the AHCCCS Daily Trip report, requested medical records, etc.).

Additionally, the DFSM Provider Training unit offers trainings with informational updates to program changes, system updates, and changes to the AHCCCS policy, AHCCCS guides and manuals.
