From April 1<sup>st</sup>, 2020 to May 1<sup>st</sup>, 2020 the population increased\* 34,975 members or 2%.

The major increases in the AHCCCS population from April 1st, 2020 to May 1st, 2020 were:

- 10,864 SOBRA Child
- 8,612 Prop 204 Restoration
- 8,515 1931 AHCCCS for Families & Children
- 5,290 Adult Expansion

There were no major decreases in the AHCCCS population from April 1<sup>st</sup>, 2020 to May 1<sup>st</sup>, 2020.
