From January 1, 2026, to February 1, 2026, the population decreased by 21,277 members, or 1%.

There were no major increases in the AHCCCS population from January 1, 2026, to February 1, 2026.

The major decreases in the AHCCCS population from January 1, 2026, to February 1, 2026, were:

- 6,387 Transitional Medical Assistance (TMA)
- 5,125 SOBRA Child
- 4,312 Prop 204 Restoration (0 - 100% FPL)
- 2,838 1931 AHCCCS for Families & Children
- 562 Adult Expansion (100% - 133% FPL)
