## NAME CHANGE

Effective April 1, 2021, Comprehensive Medical and Dental Program (CMDP) changed to Comprehensive Health Plan (CHP) due to Behavioral health integration. Refer to Laws 2019, 1<sup>st</sup> Regular Session. AHCCCS is in the process of revising all pertinent documents to reflect the new name.

## **CONTRACT NAME CHANGE**

Effective October 1, 2022, the Regional Behavioral Health Authority (RBHA) for the Managed Care Organizations was aligned with the Competitive Contract Expansion YH20-0002 to expand the provision of services for the awarded ACC-RBHA Contractors. AHCCCS is in the process of revising all pertinent documents to reflect this change.

## ACOM POLICY 438 – ADMINITRATIVE SERVICES SUBCONTRACTOR EVALUATION

ACOM Policy 438 was revised to align with the National Committee for Quality Assurance (NCQA) requirements by creating a stand-alone definition for Management Services Agreement (MSA) and removing MSAs from the definition of Administrative Services Agreements per NCQA Delegation Standards. The policy clarified the requirements of Approval of Subcontracts for MSAs and Administrative Services Subcontracts. Additional minor grammatical edits were made throughout the policy including changing the reference of Division of Health Care Management (DHCM) to Division of Health Care Services (DHCS).
