SECTION 504 OF THE REHABILITATION ACT

Effective May 1, 2024, The Office for Civil Rights (OCR) finalized the rule that prohibits discrimination on the basis of disability. AHCCCS is in the process of revising all pertinent documents to remove symbols and periods from various Federal and State citations to ensure accessibility for all individuals in compliance with <u>Section 504 of the Rehabilitation Act</u>.

AHCCCS NEW AGENCY STRUCTURE

ACOM POLICY 449 – BEHAVIORAL HEALTH SERVICES FOR CHILDREN IN DEPARTMENT OF CHILD SAFETY CUSTODY AND ADOPTED CHILDREN

ACOM Policy 449 had substantial changes below that included but were not limited to:

- Revised to align with Jacob's Law requirements.
- Clarified that the Contractor would be the one to deny the request for behavioral out-of-home treatment.
- Updated Section C heading to clarify contents of information provided.
- Revised to align with ACOM Policy 404, Contractor Website and Member Information.
- Moved pertinent information into Attachment C, Behavioral Health Utilization and Timeframe for Members in DCS Custody.
- Added pertinent information from Reserved Attachment B has been relocated into Attachment C.
