#### **AHCCCS Medical Policy Manual (AMPM)**

#### AMPM POLICY 1020, MEDICAL MANAGEMENT SCOPE AND COMPONENTS

AMPM Policy 1020 was revised for general formatting and adding of definitions for various components of utilization data analysis and data management. Policy revisions also include the DDD integration of behavioral health and language pertaining to the new contract deliverables. This policy was further revised to include updates regarding current Drug Utilization Review (DUR) pertaining to opioids, and licensing renewal standards for Physicians, Physician Assistants, and Nurse Practitioners.
