# UPDATES AND REVISIONS TO THE AHCCCS MEDICAL POLICY MANUAL (AMPM)

**AHCCCS Medical Policy Manual (AMPM)** 

## AMPM POLICY 310-D1, DENTAL SERVICES FOR MEMBERS 21 YEARS OF AGE AND OLDER

AMPM Policy 310-D1 was revised to align with A.R.S. §32-1281, 32-1289, 32-1291, which changes the scope of practice for dental hygienists, allowing dental hygienists to be supervised by a physician in an inpatient hospital setting and allows dental hygienists to supervise dental assistants if this is included in their affiliated practice agreement. The Policy was also revised to include a definition of 'Dental Provider' which replaced references of 'Dentist' with 'Dental Provider'. Language was clarified regarding ventilator cases when services are billed under the physician; specifying medical codes will be submitted and are not subject to the \$1,000 adult emergency dental limit. Policy has a retro effective date of 10/01/19.
