Information Regarding COVID-19

In response to Medicaid-related questions from providers and contractors arising from the COVID-19 pandemic, AHCCCS has developed a list of Frequently Asked Questions (FAQs) Regarding Coronavirus Disease 2019 (COVID-19) which is updated regularly. It is important to note that there are instances where the information presented in the COVID-19 FAQs does not align with provisions set forth by the AMPM. In these instances the FAQs take precedence and are controlling.

UPDATES AND REVISIONS TO THE AHCCCS MEDICAL POLICY MANUAL (AMPM)

AMPM POLICY 450, OUT-OF-STATE PLACEMENTS FOR BEHAVIORAL HEALTH TREATMENT

AMPM Policy 450 was revised to update the AHCCCS Quality Management Portal process for submittal of notifications and reports. Due dates for notifications were revised to align with the Contract and the AHCCCS Quality Management Portal requirements. Additional revisions included adding TRBHA and Fee-For-Service providers where applicable and the removal of the three in-state requirement before an out-of-state placement is made.

AMPM POLICY 660, OPIOID TREATMENT PROGRAM MID-LEVEL EXEMPTION

AMPM Policy 660 was revised to provide clarity and direct information for the Opioid Treatment Program (OTP) providers. A section was added for providers in need of exemption requests to have other prescribers perform the duties of medical directors or other prescribers.

Attachment A, has been revised based on Substance Abuse and Mental Health Services Administration (SAMHSA) requirements. An Exemptions Requested section

has been added to Identify Patient admission criteria, when released from an institutions, medication administrations, and unsupervised or “take-home” use. In addition, an Other Mid-level provider option has been added.

AHCCCS MEDICAL POLICY MANUAL (AMPM)

Pursuant to Laws 2019, 1st Regular Session, Chapter 305, behavioral health services for children in DCS custody were anticipated to transition from the RBHA Contractors to DCS/ CMDP effective October 1, 2020. However, this implementation has been delayed. Revisions that have already been completed for ACOM and AMPM Policies and Attachment(s), related to this anticipated integration [**listed in document provided below**], will remain in the impacted policies but will not be applicable until such time that CMDP behavioral health service integration is implemented. Revisions unrelated to the integration of behavioral health services for CMDP members; will continue to be effective October 1, 2020.

AMPM Policy 320-O was revised to address integration of behavioral health services into the DCS/CMDP Program effective October 1, 2020 (RFP #BPM001873). Definitions were added and revised to provide identifier clarity. Language was revised stemming from the Community Collaborative group meetings. Details were also added surrounding Crisis and Safety Planning. *Implementation Date 10/01/20.*
