Information Regarding COVID-19

In response to Medicaid-related questions from providers and contractors arising from the COVID-19 pandemic, AHCCCS has developed a list of Frequently Asked Questions (FAQs) Regarding Coronavirus Disease 2019 (COVID-19) which is updated regularly. It is important to note that there are instances where the information presented in the COVID-19 FAQs does not align with provisions set forth by the AMPM. In these instances the FAQs take precedence and are controlling.

The Contract and Policy Unit will begin transitioning the Policies from the *Approved Not Yet Effective* section of the AMPM webpage to the AMPM final publishing section. Some Policies may have additional changes since the date they were first posted to the Approved Not Yet Effective section. AMPM POLICY 550, RESERVED

AMPM 550, Member Records and Confidentiality is being reserved with pertinent information moving into AMPM 940, Medical Records and Communication of Clinical Information.

AMPM POLICY 630, RESERVED

AMPM 630, Medical Records Requirements is being reserved with pertinent information moving into AMPM 940, Medical Records and Communication of Clinical Information.



AMPM POLICY 940, MEDICAL RECORDS AND COMMUNICATION OF CLINICAL INFORMATION

AMPM Policy 940 was revised to incorporate pertinent information previously found in AMPM Policy 550, Member Records and Confidentiality and AMPM Policy 630, Medical Records Requirements. Language has been added to incorporate references to the Statewide Behavioral Health Audit Tool.

AMPM POLICY 950, CREDENTIALING AND RECREDENTIALING PROCESSES

AMPM Policy 950 was revised to include requirements for Substance Abuse and Mental Health Services Administration (SAMHSA) Certified Opioid Treatment Programs that will now be credentialed using the temporary/provisional credentialing process. Policy was also updated to reflect credentialing (certification) process for therapeutic foster care.

AMPM POLICY 963, PEER AND RECOVERY SUPPORT SERVICE PROVISION REQUIREMENTS

AMPM Policy 963 was revised to remove the applicability for all Fee-For-Service programs. Clarifying language and references to attachments were added/updated. Further updates were also added to address the integration of behavioral health services into the DCS/CMDP Program. All anticipated integration language will remain in the Policy but will not be applicable until such time that CMDP behavioral health service integration is implemented with an anticipated implementation date of April 1, 2021. Revisions unrelated to the integration of behavioral health services for CMDP members will have an *Effective Date 10/01/20*.

POST TRIBAL CONSULTATION NOTIFICATION/PUBLIC COMMENT CHANGES:

After being posted for Tribal Consultation Notification/Public Comment on June 24, 2020, AMPM Policy 963 was further revised to clarify the training curriculum standard for the advocacy and systems perspective for combating stigma and oppression.

AMPM POLICY 964, CREDENTIALED PARENT/FAMILY SUPPORT REQUIREMENTS

AMPM Policy 964 was revised to remove the applicability for all Fee-For-Service programs. Revisions included clarifications regarding credentialing of peer support, attachments were updated and references to AHCCCS/DCAIR, Office of Individual and Family Affairs (OIFA) were updated. The Policy was also updated to address the integration of behavioral health services into the DCS/CMDP Program. In addition, language was added to provide information for individuals seeking employment in a Credentialed Parent/Family Support role, to provide clarity of the importance of Credentialing Parent/Family as peer support, and an overview of steps for obtaining a credentialed role. All anticipated integration language will remain in the Policy but will not be applicable until such time that CMDP behavioral health service integration is implemented with an anticipated implementation date of April 1, 2021. Revisions unrelated to the integration of behavioral health services for CMDP members will have an *Effective Date* 10/01/20.
