INFORMATION REGARDING COVID-19

In response to Medicaid-related questions from providers and contractors arising from the COVID-19 pandemic, AHCCCS has developed a list of Frequently Asked Questions (FAQs) Regarding Coronavirus Disease 2019 (COVID-19) which is updated regularly. It is important to note that there are instances where the information presented in the CMS-approved flexibilities and COVID-19 FAQs does not align with provisions set forth by the AHCCCS Medical Policy Manual (AMPM). In these instances, the CMS-approved flexibilities and FAQs take precedence and are controlling.

NAME CHANGE

Effective April 1, 2021 Comprehensive Medical and Dental Program (CMDP) will be changing to Comprehensive Health Plan (CHP) due to Behavioral health integration. Refer to Laws 2019, 1st Regular Session. AHCCCS is in the process of revising all pertinent documents to reflect the new name.

AMPM Exhibit 300-2B was revised to correct a typographical error. "State" was removed from endnote #4. The corrected endnote #4 is as follows: "Screening/assessments may be covered for Non-Title XIX/XXI eligible members when the screening is a primary screening, and/or the screenings are being considered for admission to mental health facilities to determine the appropriateness of such admission. A secondary provider assessment and screening to decide determinations is unallowable."

AMPM Policy 310-R – Nursing Facility Services

AMPM Policy 310-R was revised to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021 due to CHP behavioral health integration. Minor clarification and formatting were done throughout the policy. AMPM POLICY 320-O, BEHAVIORAL HEALTH ASSESSMENTS AND TREATMENT SERVICE PLANNING

AMPM Policy 320-O was revised to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021, due to CHP behavioral health integration. Policy name was also updated to align with the restructuring the content to three primary sections including "Overview", "Assessment", "Service and Treatment Planning". Each section includes information specific to the actual process. The section covering crisis planning remained. Duplicative information, as well as information extraneous to required policy elements outlined under either R9-21 or R9-10 was removed. When appropriate, policy references to other policies were added. To accommodate FFS and unique needs of other provider types that may be subsumed under health home, the concept of "team" was included in the policy, with language to identify the all-inclusive nature of team, whether CFT, ART or otherwise. Definitions were removed and moved to newly created AHCCCS Contract and Policy Dictionary.

AMPM POLICY 410, MATERNITY CARE SERVICES

AMPM Policy 410 was revised to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021, due to CHP behavioral health integration. Policy was also revised to provide clarification of reporting requirements. Recommendations were added to align with family planning options to include the use of Long-Acting Reversible Contraceptives (LARC) if applicable. Additional references were added for Contractors and Providers to follow current American College of Obstetricians and Gynecologists (ACOG) guidelines and provide written member educational outreach materials. Definitions were removed and moved to newly created AHCCCS Contract and Policy Dictionary.

AMPM Policy 1020 was revised to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021, due to CHP behavioral health integration.

AMPM Policy 1020, formerly titled "Medical Management Scope and Components" was renamed as "Utilization Management" due to removing language and creating separate standalone Policies for various aspects of the Policy.

Newly revised AMPM Policy 1020 will retain the following topics: Utilization Data Analysis and Data Management, Concurrent Review, Discharge Planning, Prior Authorization and Service Authorization, Inter-Rater Reliability, Retrospective review, Clinical Practice Guidelines, and New Medical Technologies and New Uses of Existing Technologies.

Changed requirement for Contractors to conduct care coordination activities for members who have been incarcerated for 20 days or longer; previous requirement was 30 days. All Contractors must conduct pre-release care coordination activities for members transitioning out of juvenile detention jails and prisons. Removed Justice system liaison key position as its currently found in Contract. *Effective Date of 10/01/21*.
