INFORMATION REGARDING COVID-19

In response to Medicaid-related questions from providers and contractors arising from the COVID-19 pandemic, AHCCCS has developed a list of Frequently Asked Questions (FAQs) Regarding Coronavirus Disease 2019 (COVID-19) which is updated regularly. It is important to note that there are instances where the information presented in the CMS-approved flexibilities and COVID-19 FAQs does not align with provisions set forth by the AHCCCS Medical Policy Manual (AMPM). In these instances, the CMS-approved flexibilities and FAQs take precedence and are controlling.

NAME CHANGE

Effective April 1, 2021, Comprehensive Medical and Dental Program (CMDP) changed to Comprehensive Health Plan (CHP) due to Behavioral health integration. Refer to Laws 2019, 1st Regular Session. AHCCCS is in the process of revising all pertinent documents to reflect the new name.

AMPM POLICY 320-B – MEMBER PARTICIPATION IN EXPERIMENTAL SERVICES AND CLINICIAL TRIALS

AMPM Policy 320-B title was revised to Member Participation in Experimental Services and Clinical Trials. AMPM Policy 320-B was revised to align with the Competitive Contract Expansion YH20-0002 to expand the provision of services for the awarded ACC Contractors and to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021, due to CHP behavioral health integration. Additional language was added to encompass new CMS coverage guidelines surrounding clinical trials for members. *Implementation Date* 10/01/22.

POST TRIBAL CONSULTATION NOTIFICATION AND PUBLIC COMMENT CHANGES:

AMPM Policy 320-B was revised to further clarify original changes after being posted for Tribal Consultation Notification and Public Comment on 06/08/22. Changes include correcting the erroneous effective date to 10/01/22 and updating policy to include a reference to Attachment A, a CMS required attestation form on the appropriateness of the qualified clinical trial. Attachment A, the new attestation form was also added to AMPM Policy 320-B.

AMPM POLICY 320-V - BEHAVIORAL HEALTH RESIDENTIAL FACILITIES

AMPM Policy 320-V was revised to align with the Competitive Contract Expansion YH20-0002 to expand the provision of services for the awarded ACC Contractors. Added language to indicate FFS program applicability and requirements. Separated sentence regarding consent for treatment and participation of Health Care Decision Maker (HCDM) to make clearer that unless court ordered to a secured Behavioral Health Residential Facility (BHRF), members must be voluntarily admitted for treatment in this level of care. Indian Health Services, Tribally operated 638 Facility, Urban Indian Health (I/T/U) has been included into the Policy for standard alignment and BHRF documentation has been updated for clarity intent.

AMPM Policy 1240-B title was revised from "Adult Day Health Care Services" to "Adult Day Health Care Facilities" and updated to comply with the Home and Community Based Settings Rule under section 1915 of the Social Security Act [42 CFR 438.3(o); 42 CFR 441.301(c)(4)]. Requirements for Adult Day Health Facilities was added to comply with the federal mandate for HCBS Rules. *Implementation Date 03/01/23*.

AMPM POLICY 1620-D – PLACEMENT AND SERVICE PLANNING STANDARD

AMPM Policy 1620-D was revised for annual updates to align with policy standard formatting. Transportation language was added for clarification for Home and Community Based Services (HCBS). *Implementation Date* 10/01/22.
